David called to the Bar in 2012. Prior to that he had been a solicitor in private practice for a

number of years, and qualified as a solicitor advocate in 2009. David has dealt with a wide variety of cases since calling at the Bar. He is regularly instructed to provide opinions on a wide variety of matters and has appeared in the Sheriff Court, the Sheriff Appeal Court, the Outer House, and the Inner House. Some of the cases in which David has appeared are listed below in the Appendix.

The majority of David's work is in the areas of contract and property law. Insofar as contract is concerned, he has conducted cases on matters such as the interpretation of contracts, the incorporation and implication of terms into contracts, and the enforceability of penalty clauses. On the property side, he has conducted cases dealing with various matters relating to leases, cases involving the constitution and interpretation of servitude rights, and cases involving common property. He also regularly acts in cases involving other aspects of private law, including, for example, professional negligence cases. In addition to his private law work, David also has extensive experience of judicial review and regulatory work. Insofar as judicial review is concerned, he has particular experience of cases relating to prisoners. On the regulatory side, he has successfully represented registrants before professional tribunals and before the Inner House of the Court of Session. As well as advising and representing registrants, David is a legal assessor for the Nursing and Midwifery Council, a panel member of the Cricket Scotland Disciplinary Committee, and a panel member of the Scottish Gymnastics Association Conduct Committee, which has given him experience of hearing disciplinary cases and appeals, including acting as chairman.

In addition to his work as an advocate, David tutors at the University of Edinburgh. He tutors undergraduates on the LL.B Ordinary programme (Contract and Unjustified Enrichment) and on the Honours programme (Commercial Law — Insurance), and postgraduates on the LL.M (Principles of Insurance Law), and the Diploma in Professional Legal Practice (Civil Court Practice). He is the Senior Tutor on the Civil Court Practice Course. In addition to that, having played cricket competitively for a number of years, he now umpires in one of the top leagues in Scotland. He officiated as an on-field and third umpire in a number of matches in the ICC World Cricket League, Europe Division 2, in Sweden in 2016. He has also officiated a number of domestic finals, including the 2018 Scottish Cup Final.
