Kirsty has a varied civil litigation practice at the Scots Bar, encompassing commercial, reparation, and contentious property and executry, cases. Her particular expertise, however, is in private international law (i.e., dealing with questions of jurisdiction, choice of law, and recognition & enforcement, arising across the spectrum of private law). She is recognised as an expert in intra-UK private international law matters, having written the leading textbook on this subject (Conflict of Laws within the UK (OUP)). Her publications are in the area of private international law (and its interaction with the UK's constitutional structure), and court practice and procedure. In October 2014, she became the first woman to be elected as Clerk of Faculty at the Faculty of Advocates: a position she held until April 2019.
